Eligible Professional / Eligible Clinician eCQMs for 2024

Electronic clinical quality measures (eCQMs) are tools used by CMS to help measure and track the quality of healthcare services provided by eligible professionals. Any eligible provider participating in the Quality Payment Program can use AdvancedMD EHR to collect data, track their performance scores and report on any of the eCQMs supported by AdvancedMD. The following eCQMs are supported by AdvancedMD in to be used for the Traditional MIPS CMS QPP program.
