DATA EXPORT C-CDA IMPLEMENTATION: Single patient data export data elements are pulled from various areas within the EHR as well as from coded note templates that have been set up with the correct LOINC and SNOMED codes. It is highly recommended to use the Outbound Clinical Information Exchange (CIE) note template to collect/capture fields for C-CDA data exports. Download the Outbound CIE template from the EHR Template Library. Below lists the data export sections, data included, required codes if necessary and instructions for proper implementation.
